Data Privacy Statement for Association Judges of the JGHV

I,	VR - nr.:
have been informed that as an association judge , I am prohibited from processing personal data or data related to persons without authorization in my activities as an association judge . Therefore, this data may only be processed, if consent or a legal regulation authorizes data processing or if such processing is required. The principles of the DS-GVO for the processing of personal data or data related to persons are set forth in Article 5 (1) of the DS-GVO and essentially include the following obligations:	
Personal (e.g., name, address) and data related to persons (e.g., kennel name) must, in particular:	
a) be processed in a lawful manner and in a manner that is comprehensible for the person concerned (e.g. by using up-to-date forms, explicit consent to old forms, reference to the JGHV data privacy statement and data processing directory);	
b) are collected only for the purposes of the association as set forth in the bylaws of the JGHV and may not be further processed in a manner incompatible with these purposes (e.g. exclusive dissemination of test data only to those previously specified in the data protection declaration / in the data management directory);	
c) be factually accurate and, if necessary, up to date; all appropriate measures must be taken to ensure that personal data, which are inaccurate for the purposes of their processing, are corrected without delay (e.g. by reconciling the data on the pedigree or the hunting license with the details on the entry form);	
d) be processed in a manner which ensures adequate security of personal data, including protection against unauthorized or unlawful processing and against accidental loss, accidental destruction or accidental damage through appropriate technical and organizational measures (e.g. secure storage of the test documents);	
Violations of this obligation, regardless of whether this Declaration of Obligation is signed, can now be punished under the Data Protection Act with a fine and / or imprisonment. Also, (civil / association) claims may result from culpable violations of this obligation.

Explanatory Notes:

Dear Verbandsrichter,

In the June issue of 2018 of our association magazine "Der Jagdgebrauchshund", our data protection officer introduced you to the new data protection law. This article can also be found on our homepage under the heading "Data Protection".

The new data protection law should better protect data. This happens among other things by better informing those concerned about their rights. However, this also means that all those who have to observe data protection in their work are urged to be aware of their duties. Of course, this also applies to voluntary work and thus also to you as an association judge.

Lawmakers also hope for effective data protection by, among others, obligating clubs and associations to prove at any time that they have instructed office holders and functionaries about statutory data protection before any damage can be incurred. Only then, from the lawmakers' point of view, is it ensured that those affected will be effectively protected from abuse right from the beginning, as well as office holders against later liability. For initial ignorance does not protect against later liability or even punishment.

For this purpose alone, we would like to ask you to confirm with us on the attached tear-out form, that which has long been a matter of course for all of you. Your legal liability already exists and will not be extended by the form.

We have formulated the Declaration of Obligation in such a way that it is easy to understand for everyone. If you still have questions, do not hesitate to ask us. We fulfill a legal obligation with this form. Support us by promptly handling and returning the form to the office of the JGHV.

This is the only way to protect what we care about: versatile hunting dog affairs based on reliable data.
